**SUBJECT: Appointment to fill an Existing Board Vacancy** 

#### STAFF RECOMMENDATION:

Interview and Select a Candidate to fill an existing Board of Directors vacancy for the remaining term that expires December 2022.

#### **BACKGROUND DISCUSSION:**

The resignation of Ashley Sangster in November 2021 left a vacancy on the Board of Directors for the remaining term of office that expires in December 2022.

A Notice of Vacancy was posted in public locations within the community and posted on the District's website on November 22, 2021. Notice of vacancy was also sent out in all District water bills in December 2021.

#### **ACTION DISCUSSION:**

Letter of interest and qualifications have been submitted to the Board for consideration.

It is appropriate to interview these candidates and seek information that will lead to a Board decision regarding the prospective candidates. The Board has elected to interview these candidates regarding their qualifications the Board should consider the following format:

- 1. Interview each candidate separately, by asking all candidates to step out until called.
- 2. Give each candidate 2 minutes to state reasons and qualifications for filling the Board vacancy.
- 3. Ask questions, from the list that has been prepared, related to duties and responsibilities of Board Member.

After the interviews are completed, have public comment, hold Board discussions as needed, then proceed with a Board vote.

Following the Board's action, staff will advise the County Clerk's office of the appointment and provide appointee information as required.
